2nd BIS Resolution (15th July 2024), which allocates scholarships for incoming staff mobility from partner countries under the Erasmus+ KA171-2023 Programme

Once the first selection process established in the **2nd BIS call for applications Erasmus+ KA171-2023 scholarships for staff from partner countries** (Mobilities during the 2023-2024, 2024-2025 and 2025-2026 academic years, always before 31st July 2026 is finished.

I HEREBY RESOLVE:

<u>First</u>. Provisionally award scholarships from funds of the European Commission to the staff from partner countries listed in the annex attached to this decision in accordance with the criteria set out in the call for applications approved by the *Comissió de Relacions Internacionals i Política Lingüística* of 9th November 2023.

<u>Second</u>. The final award of these scholarships will not occur until the staff is effectively registered at the Universitat Autònoma de Barcelona and has completed all the procedures required in accordance with the conditions of the call.

<u>Third</u>. The mobilities and scholarships will be subjected to the regulations and restrictions that might be issued by the authorities, in relation to unforeseen and/or emergency situations that may occur.
