

3rd Resolution (December 16, 2024), which allocates Erasmus+ KA171-2023 scholarships for incoming staff mobility from third countries not associated to the Programme

Once the first selection process established in the **3rd call for applications Erasmus+ KA171-2023 scholarships for staff from third countries not associated to the Programme** (Mobilities during the 2024-2025 and 2025-2026 academic years, always before 31st July 2026 is finished.

I HEREBY RESOLVE:

First. Provisionally award scholarships from funds of the European Commission to the staff from partner countries listed in the annex attached to this decision in accordance with the criteria set out in the call for applications approved by the *Comissió de Relacions Internacionals i Política Lingüística* of 9th November 2023.

Second. The final award of these scholarships will not occur until the staff is effectively registered at the Universitat Autònoma de Barcelona and has completed all the procedures required in accordance with the conditions of the call.

Third. The mobilities and scholarships will be subjected to the regulations and restrictions that might be issued by the authorities, in relation to unforeseen and/or emergency situations that may occur.

(*) The 2 extra days of subsistence are for travel and will only be paid if the person travels from the country where their home university is located to the country where the host university is located

(**) The Travel amount is calculated depending on the distance between the institution of origin and the institution of destination according to the European Commission's regulations. This amount will only be paid if the person is in the country of their home university before the start of the mobility period and provides proof by submitting a copy of their flight ticket.

It will be needed the signature of an Inter Institutional agreement between the UAB and the University of origin to have exemption of paying taxes.

The scholarships will be subject to have all the required documents before the end of the cure period (10 days after resolution is published).
