

## **4<sup>th</sup> Resolution (January 29, 2025), which allocates mobility grants under the Erasmus+ KA171-2023 to incoming students from third countries not associated to the Programme**

Once the first selection process established in the **4th call for applications Erasmus+ KA171-2023 grants to incoming students from third countries not associated to the Programme** (Mobilities during the 2024-2025 and 2025-2026 academic years, always before 31<sup>st</sup> July 2026 is finished)

I HEREBY RESOLVE:

First. Provisionally award scholarships from funds of the European Commission to the students from partner countries listed in the annex attached to this decision in accordance with the criteria set out in the call for applications approved by the *Comissió de Relacions Internacionals i Política Lingüística* of 9<sup>th</sup> November 2023.

Second. The final award of these scholarships will not occur until the student is effectively registered at the Universitat Autònoma de Barcelona and has completed all the procedures required in accordance with the conditions of the call.

Third. The mobilities and scholarships will be subjected to the regulations and restrictions that might be issued by the authorities, in relation to unforeseen and/or emergency situations that may occur.
