ACCREDITATION PROCEDURE FOR STUDENTS HOLDING AN OFFICIAL FOREIGN UNIVERSITY DEGREE IN PSICHOLOGY, FOR ACCESS TO THE MASTER'S DEGREE IN GENERAL HEALTH PSYCHOLOGY (MUPGS)

With the entry into force of the *Organic Law on the University System* (LOSU), any official foreign university degree in Psychology that meets the requirements established in the LOSU will be valid for access to the Master's Degree in General Health Psychology <u>Order CNU/1309/2018</u>, of 5 December.

Interested parties may apply for accreditation of the requirements recognised in Order CNU/1309/2018 by applying to one of the universities in the Spanish university system that offer the Master's degree in General Health Psychology, while respecting the administrative procedures and deadlines established by each university for this purpose.

The Conference of Deans of Psychology of Spanish Universities (CDPUE) set up a Committee for the Accreditation of Psychology Studies (CAEP), which will depend on the CDPUE, as stated in Order CNU/1309/2018, for the analysis of degree certificates and the accreditation that the degrees analysed meet the requirements of the Order, as set out in the Resolution of the General Secretariat for Universities, which published the Agreement of the Council of Universities, which establishes recommendations for the accreditation of compliance with the requirements established in Order CNU/1309/2028, of 5 December, for access to the Master's Degree in General Health Psychology based on official foreign university degrees in Psychology.

The CAEP will issue a proposed resolution that will include an assessment of the fulfilment of having taken the required credits in each area of knowledge, in accordance with article 1 of the Order CNU/1309/2018. The proposal will be sent to the university receiving the accreditation application. The university will issue the final decision and send it to the interested party.

The resolution will be either:

ACCEPTED, which will allow you to take part in the admission processes for the Master's Degree in General Health Psychology at any of the universities in the Spanish university system.

To access the Master's Degree in General Psychology taught at the Universitat Autònoma de Barcelona (UAB) it will be necessary to carry out the ordinary preenrolment process within the <u>established deadline</u>.

CONDITIONAL ACCEPTANCE, depending on whether the degree under evaluation contains at least 50% of the required credits or not.

Any pending credits will be listed in the resolution issued by the university. This report will make it possible to apply to pass the credits at any of the universities in the Spanish university system that offer a Bachelor's degree in Psychology.

Applications from students who wish to pass these credits at the UAB will be accepted using the same procedure used for students who hold a partially recognised degree.

Once the pending credits have been taken and passed, students can take part in the admission processes for the Master's Degree in General Health Psychology at any of the universities in the Spanish university system.

REJECTED, it will not be possible to access the Master's degree in General Health Psychology.

SUBMISSION OF APPLICATIONS FOR ACCREDITATION TO THE UNIVERSITAT AUTÒNOMA DE BARCELONA (UAB)

ADMISSION REQUIREMENTS FOR APPLICATIONS:

- (1) Having obtained an official university degree in Psychology from a university abroad, whether it is located within the EU or not, with a total course load of 180 ECTS credits (or 1.800 teaching hours).
- (2) Having taken and obtained at least 90 ECTS credits (or 900 teaching hours) in subjects related to Health Psychology.

PROCEDURE:

Interested parties should fill in the following online form and attach the documentation listed below:

- (1) Document accrediting the identity and nationality of the interested party, issued by the competent authorities of the country of origin or provenance.
- (2) In the case of persons resident in Spain it is necessary to present a declaration authorising the UAB to check and verify their identity. If the person does not provide their consent for this verification, they must present a copy of a document (which must not have expired) proving their identity.
- (3) Degree certificate to be accredited or a certification of its issue to be accredited instead. Except in the case of qualifications from the EU, Iceland, Liechtenstein, Norway and Switzerland, the documentation must be legalised through diplomatic channels or with a Hague apostille and be accompanied by a sworn translation into Spanish, if applicable.
- (4) An academic certificate which must contain:
 - The official duration of the study programme in academic years
 - o A list of the subjects taken and the hours of study for each one
 - The corresponding ECTS credits
 - o The marks awarded for each subject.

With the exception of qualifications from the EU, Iceland, Liechtenstein, Norway and Switzerland, the documentation must be legalised through diplomatic channels or with a Hague apostille and be accompanied by a sworn translation into Spanish, if applicable.

- (5) Course guides or curricula for the subjects taken.
- (6) The full curriculum of the degree programme taken.
- (7) Proof of payment of the transcript of records fee (€54.54, for the academic year 2025-26). Pay via bank transfer to the following UAB BBVA account ES48 0182 6053 43 0201609886.
- (8) A declaration by the applicant declaring the veracity of the data provided, as well as the fact they hold in their possession the original documentation required for this process.
